**CANCELLATION, TERMINATION & REFUND POLICY**

TURNER TRADE SCHOOL INC. reserves the right to reject any application for admission, or to terminate a student for reasons of scholarship, attendance, conduct, arrears in payment or not conforming to the rules and regulations of the school, as described in the school catalog.

**REFUND POLICY:** A student may cancel this agreement at no penalty by notifying the school in writing seven days after midnight of the day on which this agreement was signed, provided the student has not entered into instruction.

After this seven day period and before the student has entered into instruction, if the student cancels this agreement, the school will retain the registration fee of one hundred (\$100) dollars, plus the accrued value of any books and supplies distributed to the student up to \$325.00.

Once the student has entered into instruction, a student will be liable for tuition as of the student's last day of physical attendance. Tuition liability is divided by the number of terms in the program. Total tuition liability is limited to the term during which the student withdrew or was terminated, and any previous terms completed.

**FIRST QUARTER & SECOND QUARTER**

*If termination occurs, School may keep:*

Prior to and during the first week .....	0%
During the second week .....	25%
During the third week .....	50%
During the fourth week .....	75%
After the fourth week .....	100%

Any monies paid to the school in excess of the sum due the school by the student who cancels, withdraws or is discontinued will be refunded within thirty (30) days after notification in writing. The date of withdrawal by the student is the last day of attendance.

**COURSE COMPLETION:** Certificates and transcripts will not be issued, nor placement service provided, unless the student has met all requirements including the satisfying of all monetary obligations.

**PLACEMENT ASSISTANCE SERVICE:** While placement service may be provided, it is understood that the school cannot promise or guarantee employment to any student or graduate.

It is understood that this application contains all the terms of the agreement and can only be changed in writing and signed by both parties. I understand that there is no interest charge for any installment payment inasmuch as the cost of the tuition is the same whether paid in advance or in installments.
